ACTION ALERT!

Testimony in budget hearings by the Utah Inland Port Authority and State Institutional Trust Lands Administration (SITLA) revealed that both are moving ahead with plans to develop a new railyard – and will be seeking state funding for this effort. (See Budget News) This rail-to-truck transfer facility has been described as the “lynchpin” to the success of the Port, but it has not been discussed publicly for more than a year.

Call your legislators and tell them to insist that UIPA come clean with their plans for this dirty new railyard. The public's right-to-know what is being done with our tax dollars is at stake. Tell legislators that NO public money should be spent to develop this transfer station unless and until UIPA and SILTA make a public commitment to conduct a full environmental impact analysis!

News of Week Two (Week # 2)

We're told that the bill to merge DEQ and DNR and will be unveiled this week. It has produced strong opposition and may have lost some momentum, but stopping this hostile takeover remains a top priority.

Meat producing conglomerate Smithfield Foods and their lobbyists are behind SB 130, which would require most counties to designate lands where gigantic animal farms (CAFOs) may be built. These monster farms threaten surface and groundwater, air quality, and quality of life. So much for "local control". We object!

SJR 7, the resolution to grant legislative approval to Energy Solutions for a new landfill for slightly radioactive rubble from decommissioning nuclear power plants nationwide won easy Senate approval and now heads to the House for further debate.

Budget News

The Utah Inland Port Authority is requesting \$2.8 m. more in on-going funds for admin. And \$1.1 m. one-time for work on the "trans-loading facility", i.e. the new highly-prized rail-truck transfer station on SITLA-owned land. SITLA is seeking funding and legislation to "clean up" the old SL City landfill just north of I-80 at 7200 W. for that.

We are hearing rumblings that there may be as many as three separate appropriations or line items for Colorado River projects, which likely involve the stalled Lake Powell Pipeline project. It's unclear how Utah can negotiate its way around the veto of the LPP by the other six other Compact states.

Both the House and Senate passed the Base Budget bills last week, and now begin the process of sorting through and prioritizing requests for "new" money to add to programs and services. This will continue through week 3, then be put on hold until February revenue projections are released and the final rush to finish the budgeting process concludes during the last week (7).

What's Ahead

We've learned that there will be a bill emerging soon to establish a Utah Lake Authority modeled after the UIPA (sponsor Rep. Brammer, R-Highland). The bill would usurp taxing and zoning authority around the lake, violate the Public Trust, and pave the way for the development of the ridiculous "Fantasy Islands of Utah Lake". Stay tuned!

Schedules remain the same as last week. Appropriations Subcommittees meet each morning from 8:00-10:50. NRAEQ Appropriations meets on Monday, Wednesday and Friday. Standing Committees meet each day from 2-5. Both chambers will be on the floor each day from 11 to 11:50.
