About the Legislative Update

The Legislative Update is made possible by the Utah Audubon Council and contributing organizations. Each Update provides bill and budget item descriptions and status updates throughout the Session, as well as important Session dates and key committees. The Legislative Update focuses on legislative information pertaining to wildlife, sensitive and invasive species, public lands, state parks, SITLA land management, energy development, renewable energy and conservation, and water issues. The Update will be distributed after each Friday of the Session. We may also send out additional Action Alerts during the Session as issues arise that need quick action. We hope each Update issue will prepare you to contact your legislators with your opinions and concerns!

ACTION ALERT!

As expected, legislative leadership landed their big inland port bill late in the game to minimize scrutiny, as SB 243 will do with millions of dollars of taxpayer subsidized loans for private business cronies. It gets its one and only committee review and public comment Monday morning at 8 in Senate Government Ops. Call your Senators, Reps and the Governor to object to this unaccountable, unneeded state "bank" to promote environmentally disastrous port development!

Also up in committee tomorrow (SNRAE at 4) is SB 176 - to use monies federally designated to mitigate community impacts from fossil fuel extraction to facilitate construction of the Uintah Basin Railway. This runaway oil train through spectacular Utah canyons looks like a runaway through the Legislature nostalgic for the goodle boom and bust days - unless we can derail it. Call Reps and the Gov and let them know what you think of this!

News of Week Six (Week # 6)

The Best News of the Week **was** the resounding defeat of HB 364, Utah Lake Authority (ULA), by the House NRAE Committee. Opposition to the bill came from a range of interests, including the "water community", Utah Farm Bureau, conservationists, and some cities. **Until** late Friday when EAC appropriated \$9.8 m. to the ULA for "lake restoration". It's unclear if the bill now must pass, or if projects can begin without it.

Conservation and clean energy advocates high-fived the defeat on the House floor of HB 209, the fee hike on electric vehicles. SB 61, a bad billboard bill, failed on the Senate floor, but so did SB 168, the effort to let Moab restrict UHVs nighttime use of streets in town. Also positive news was the House passage of HCR 18 to extend and expand RECA, and of HB 399.

But some bad new bills: SB 233 gives MIDA more power and secrecy (and budgeters gave MIDA \$45.6 m. to subsidize infrastructure for new strategic missiles and a luxury ski resort for top brass). SB 240 would undermine planning and water quality in Big Cottonwood Canyon to benefit development interests.

Budget News

Executive Appropriations (EAC) met Friday and essentially finalized the budget decisions. A mixed result, as always.

There were some positives for the environment: State Parks was the big winner with over \$67 m. in new investments. GSL Groundwater Studies: \$750k 1-time; Water/Land Use Planning: \$270k 1-t; Ag Water Optimization: \$3 m. 1-t; LeRay McAllister Open Space Preservation: \$1 m. 1-t.

Adoption of the budget bills is mostly a formality from here. All the money bills must be passed by Wednesday at noon. Caucuses must set their priorities for inclusion in the "Bill of Bills" by Tuesday. Some good bills were funded by EAC's action Friday: SB 15 for \$49,000 1-time, HB 381 for \$250k 1-t, and HB 224 for \$130k on-going.

What's Ahead

Final Week! The last Standing Committees will meet from 8-10 AM and from 4-6 PM Monday and from 8-10 and 2-4 on Tuesday through Friday. Both chambers will be on the floor the rest of the time and will go as late as needed until sine die at midnight Friday. Wednesday is the last day to consider bills originating from own house, so Senate does House bills only and vice versa. Also they will "wipe the boards" Wednesday, giving the respective Rules Committees control of the floor voting queue. Hang on to your hats!
